Clinical Advisors in Audiometry Nursing 2023

A Teams workshop will be provided to those who wish to maintain or become an accredited Clinical Advisor for Audiometry Nursing students studying with the Australian College of Nursing.

Clinical advisors are essential to assist Audiometry nursing students in their clinical placement and to deem them competent to practice as an Audiometry Nurse.

Accreditation should be renewed every three years.

Criteria for accreditation as Clinical Advisor in Audiometry Nursing

- Evidence of Audiometry nursing qualification <u>attach copy for new application</u>
- Preferable (not compulsory) to hold Certificate IV Workplace Training and Assessment or equivalent (current enrolment if recently applied) – <u>attach copy</u>.
- Recent audiometry nursing experience.
- Experience testing all age groups where current job description does not include assessment of all age groups, please arrange student to gain this experience with another experienced/competent Audiometry Nurse.
- Current financial member of ANAA Inc.
- Endorsed by ANAA Inc if you are an audiologist.

Applicants will be required to:

- Complete a case study in which I will send the criteria on receipt of your application.
- Attend a 2-hour workshops via Teams, Thursday 12th October 2pm to 4pm.

 Present your case study to ANAA Inc. members at the ANAA Inc. Conference 19th October 2023 (negotiable)

CoNNMO Member Meeting- Friday 5th May 2023

Acknowledgement of the International Day of the Midwife 2023 by Dr Margaret Gatling-ANMAC

The First Nations women were amongst the first Midwives in Australia. The theme for the upcoming Midwifery conference in Bali is "Evidence to Reality".


Common insecticides may affect hearing.

Pyrethroids are commonly-used but we know little about their effect on the auditory system.

Although previous studies have reported the relationship between pyrethroids and neurotoxicity, little is known about the effect of pyrethroid exposure on the auditory system among the general population. A recent study in the U.S. shows a possible link to changes to hearing among younger people.

The study found that pyrethroid insecticides were prone to be more toxic to auditory systems in younger adults than in older ones. <u>Plos One</u>





Almost everyone has experienced the challenge of understanding someone talk in a noisy situation like a crowded restaurant, but there are many people who struggle far more than most to understand speech in noisy environments.

Having significant difficulty with speech in a noisy place is one of the earliest indications of a hearing loss and a good reason to get a hearing test.

Unfortunately, there are many people who do get their hearing tested at a hearing healthcare clinic hoping to receive help for their difficulty with speech in noise only to be told by the clinician that they have "normal" hearing because the standard hearing test didn't reveal any hearing loss.

This condition is termed "hidden hearing loss", coined by Macquarie University <u>Professor David</u> <u>McAlpine</u>, and refers to the condition where someone has speech-understanding difficulties similar to someone with hearing loss but without any clinical evidence that they have an actual hearing loss — their hearing problems are "hidden".

Australia's National Acoustic Laboratories has conducted research into this issue, which is believed to affect millions of Australians.

NAL researchers have investigated the cause of hidden hearing loss, tested methods to "unhide" it, and developed innovative technology solutions to improve understanding speech in noise.

Apple AirPods Pro, for example, have been shown by NAL researchers to help people with hidden hearing loss, although many people are uncomfortable wearing these devices in social situations.

Technology developed at NAL was also licensed by a California tech company for use in an iPhone accessory to help with speech in noise understanding.

NAL Director Dr Brent Edwards said, "The number of people in Australia with hidden hearing loss quite likely rivals the number of Australians who have an actual hearing loss, yet there are few if any solutions provided for this population."

"We are working with clinicians at Hearing Australia to help "unhide" this problem and develop solutions to improve their speech understanding in noisy situations, with the potential to improve the lives of millions of people who are being challenged to fully engage in noisy social situations."

Other researchers are investigating potential treatments for hidden hearing loss, such as drugs that can promote the growth of new synapses or enhance the function of existing ones. Some studies have also looked at whether certain types of auditory training or brain stimulation techniques can improve the ability of people with hidden hearing loss to better understand speech in noisy environments.

Hearing loss is also called an invisible disability because you can't tell someone has hearing loss by looking at them.







Review Role of Biofilms in Children with Chronic Adenoiditis and Middle Ear Disease

Conclusions:-

Taken together, **the current evidence documents the large prevalence of bacterial biofilms in adenoidal and middle ear samples taken from children with chronic adenoiditis** with or without middle ear disease.

This finding could suggest that otopathogenic nasopharyngeal biofilm is involved in the development and perpetuation of chronic adenoiditis.

Subsequently, chronic biofilm-sustained adenoiditis may act as a possible risk factor to exacerbate adenoiditis-associated middle ear infections by predisposing some patients to developing independent and recalcitrant recurrent or chronic middle ear diseases such as RAOM, CSOM, and chronic otitis media associated with cholesteatoma.

The involvement of bacterial nasopharyngeal/adenoidal biofilm in OME is questionable.

In addition, in most studies, it is unclear whether biofilm producers are indeed highly and potentially virulent due to as over-producing toxins, having high biological fitness and/or being highly adhesive, or whether biofilm is solely generated as a result of repeated or chronic infections, when then act as dormant cells.

Therefore, no definitive conclusions about the pathogenic role of nasopharyngeal/adenoidal biofilm in the development of middle ear disease can be drawn.

Surgical debridement is still the treatment of choice for eradicating nasopharyngeal biofilms, but scientific efforts should be made to test alternative non-surgical treatment strategies Remember we have an education fund to support our Members to attend these events.
